THEY ARE EXPENSIVE AND ARE NOT COVERED BY ANY GOVERNMENT ASSISTANCE PROGRAM. WESTSIDE BABY FILLED THIS GAP IN 2021 BY PROVIDING MORE THAN 2,470,790 DIAPERS TO FAMILIES IN NEED. THIS PROGRAM SUCCEEDS IN PART DUE TO DIAPER DONATIONS BY INDIVIDUAL FAMILIES AND DIAPER DRIVES AS WELL AS NATIONAL SUPPORT FROM THE NATIONAL DIAPER BANK NETWORK AND THE KIMBERLY CLARK CORPORATION.
